



Compassion

ENTRY DEADLINE IS: December 8, 2005

DESCRIPTION: In this age of uncertainty it is necessary to affirm on an ongoing basis those positive and enduring qualities of life and spirit that enforce our humanity. "Compassion" is a conceptual, spiritual theme meant to evoke a variety of interpretations. Some images may be literal illustrations of compassion as encountered in our daily lives and others may be more abstract expressions of our subliminal compassionate feelings in response to people, events, our environment and nature.

This exhibition will consist of approximately 50 images to be hung in the lobby hallway and conference room areas of St. Vincent's Hospital, 12th St. and 7th Avenue in Manhattan. Subjects not acceptable are nudity, erotic depictions, or violence per the hospital's guidelines. Viewing will be available 24/7 with camera surveillance in the hallway; the conference room will be locked at night. The hospital will not provide additional insurance. No sitting is required. Sales are permitted. The exhibition will hang for approximately 2 months, from February 16th until April 20th, 2006. A reception on Feb. 16th will be catered by St. Vincent's. In addition, they will provide a poster, press release, announcement cards and images on their Web site.

ELIGIBILITY: This is a members only juried show open to all current PWP members paid up to date. All types of image-based work including abstract, manipulated, digital, traditional, photcollage, montage and alternative processes may be entered. Maximum size is 24" x 30" or less in height and width, including frame.

JUROR(S): Principal organizers of the exhibition

ENTRY PROCEDURE: Entries will be juried from 2" x 2" 35mm paper or plastic mount slides; 8"x10" or 8.5"x11" prints. One slide/print per image. **SLIDES:** Label slides on side from which work itself would be viewed with name of photographer, title, medium/process, size of image framed (H x W) with an arrow indicating top in the upper right corner and a red dot in the lower left corner. **PRINTS:** should be similarly labeled on back of print. **EXHIBITION FEE:** \$25 FOR 5 SLIDES OR PRINTS. Make check or money order payable to PWP. Include a SASE with sufficient postage for return of slides/prints and a duplicate entry form, which will indicate acceptance/rejection of images. Please submit duplicate slides only as slides of accepted work will be retained for the PWP archive. **NOTE:** Those submitting prints as entries will need to provide a slide of accepted work.

Fill out the entry form (below). Mail or hand-deliver forms, exhibition fee, SASE and slides to Catherine Steinmann, 1185 Park Ave, Apt. 4H, New York, NY 10128.

ACCEPTED WORK: An exhibition quality print must be delivered to The Development Office, St. Vincent's Hospital, 12th St. & 7th Ave., NYC on (date and time to be determined)]. Bring a current resume. All accepted work must be framed in either black or silver metal frames and in accordance with professional standards and must be sturdy and secure. No clip frames or plastic frames will be allowed. No substitutes of accepted work will be allowed. Submitted work must be available for the entire exhibition. Pick up of work will be on (date and time to be determined). If you cannot deliver or pick up on the specified dates, use an agent. The opening reception will be on February 16th, 2006 from 6 to 9pm.

COMMISSION: The price indicated on the entry form will be considered the retail price. St. Vincent's Hospital will retain a 15% commission on all sales. PWP requests a 10% donation on sales.
