ENTRY DEADLINE: May 8, 2007

THEME: No theme.

ELIGIBILITY: This is a body of work exhibition, sponsored by Gallery 225, located at 225 West 14th Street (between 7 & 8th Avenues), NY, NY 10011 (see www.pwponline.org, Vendors, for more information on gallery). Gallery owner-director Peter Wallach, assisted by photographer Victor Friedman (www.victorfriedman.com[<http://www.victorfriedman.com>]) will curate the exhibition. The exhibition is open to all current PWP members paid up to date.

PWP members are asked to present print portfolios of from 10-12 images for consideration. Six portfolios will be selected. Each photographer will display 6-8 images, depending on size. (If individual photographers present very large images, the number an individual could exhibit would be less than 6-8, because of space considerations.) All types of photography-based work may be entered, including digital, alternative processes, photo collage and montage.

ENTRY PROCEDURE: Please submit finished prints only to Gallery 225 at the above address, on Tuesday, May 8, between 10:00 AM–1:00 PM. Prints must be delivered unmatted, in a standard portfolio box. Any entries delivered after 1:00 PM will not be considered for exhibition. Portfolios will be juried that afternoon, and entrants will be notified of acceptance into the exhibition at pick up time, which is 6:00 PM. **Please be prompt. Failure to pick up portfolios will cancel admittance to the show.** If you cannot deliver or pick up, use an agent, but personal pick up and conference with the curator is desirable. Submission to this exhibition includes no guarantee of acceptance.

There is no exhibition fee.

ACCEPTED WORK: An exhibition quality print that is framed and matted to professional standards, in simple wood or metal, black or silver frames, which are sturdy and secure, must be delivered to Gallery 225 in late June, **(DATE AND TIME TO BE DETERMINED)**. (14th Street Framing Gallery can provide framing services at a discount to PWP Members, as indicated under Vendor Information at www.pwponline.org; or, please feel free to use your own frames and/or framers.) No clip frames or plastic frames will be allowed. Please bring a current resume/biography and artist's statement for inclusion in an exhibition guide. No substitutes of accepted work will be allowed. Submitted work must be available for the entire exhibition. Gallery 225 will supply exhibiting artists with post card invitations, listing exhibitors.

Pick up of work will be on **(DATE AND TIME TO BE DETERMINED)**. If exhibitors cannot pick up on the specified dates, please use an agent. **Work that is not picked up cannot be stored by gallery.**

GALLERY INFORMATION: The aim of the gallery is to feature contemporary and traditional artists living and working in New York and the metropolitan area. (While the gallery's primary focus is photography, work in other media is sometimes exhibited.) GALLERY 225 is open seven days a week, Monday-Saturday, from 10 AM to 6:00 PM, and on Sunday, from noon to 6:00 PM. Gallery will provide limited insurance for displayed photographers. **PWP will not be required to provide staffing, administrative or sales services.**

RECEPTION: A reception will be held for exhibitors and friends on June 28, 2007, from 6:00-8:00 PM, at the gallery. Gallery will organize and staff the reception but PWP will provide white wine and plastic cups. No food is permitted. Gallery will provide staff to serve these refreshments.

COMMISSION: The gallery will retain **50%** commission on all sales, with 50% commission to the artist. PWP will waive its standard request of 10% donation on sales. The price indicated on the entry form will be considered the retail price. Please include the Entry Form, below, with your portfolio submission.
